By joining this program, you will **not** receive these statements by mail.

- You have the right to withdraw this consent at any time by sending a signed written letter by certified mail return receipt requested or by email to the Authority, providing your name, account number, and service address.
- Once enrolled in the eBill Program, you are responsible for ensuring receipt of the email. The Authority will email your water bill and urgent notices (if applicable) to the email address that you provide, however if you fail to receive the email, you are still responsible for all charges on the account by the due date. While the Authority makes every attempt, it cannot ensure any electronic delivery.
- To update or change your email address you must complete a new eBill Authorization Form.
- Failure to receive or view the bill, or failure to notify the Authority of any e-mail address changes, does not waive penalties. The account will still be subject to disconnection due to non-payment. Automatic bill pay/direct debit options are available.
